The City Council met on Tuesday January 15, 2019 at 7:00 p.m. for a Regular scheduled meeting. The meeting was called to order by Mayor Thomas J. Kedley. With the following present: Council Members: Dave Walkup, Doug Gay, Dan Hooper, Dennis Page (Phone) and George Fotiadis. City Staff present were Ty Wheeler— City/Administrator/Clerk, Britanee Ward-Case – Accounting Manager/Assistant City Clerk and Marty Duffus – City Police Chief. Also in attendance was Bill Trickey, Seid and others who didn't sign in.

Motion by Fotiadis and second by Gay to approve the agenda; Roll call vote: Page, aye; Hooper, aye; Walkup, aye; Fotiadis, aye; Gay, aye; Motion carried.

Mayor update Council on quality of life within the City.

Steve Sied with the Clarke Community School District appeared before the Council to request concurrence to permit the school to use gravel to construct the new bus barn parking lot. Mr. Sied advised he believed the district could pave the parking to meet the City's comply with the City's ordinance at some point in the future, but not immediately due to budget constraints. **RESOLUTION 2019-04 RESOLUTION SETTING A PUBLIC HEARING FOR THE CONVEYANCE OF PROPERTY TO THE CLARKE COMMUNITY SCHOOL DISTRICT** WHEREAS, the City Council of the City of Osceola has proposed conveying interest in real property to Clarke Community School District, described as follows: The North 64.5 feet of the Northwest Quarter (1/4) of Block 14 East Osceola, and locally known as 301 S. Kossuth, Osceola, Clarke County, Iowa. WHEREAS, Clarke Community School District has proposed conveying interest in real property to the City of Osceola, described as follows: All that part of the North 66 feet of the South 169.7 feet of the southwest one-fourth of the Southwest Quarter (SW ¼ SW ¼) of Section 8, Township 72 North, Range 25 West of the 5th P.M., lying West of the center-line of U.S. Highway #69 as now located AND The East Sixty-Six (66) feet of the South 169.71 feet of the Southeast Quarter of the Southeast Quarter (SE ¼ SE ¼) of Section Seven (7), Township Seventy-two (72) North, Range Twenty-five (25) West of the 5th P.M., Clarke County, Iowa. WHEREAS, it is appropriate to publish a Notice of the proposed conveyance and of the hearing and to receive and consider objections and petitions. NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Osceola that a public hearing shall be set on February 5th, 2019 at 7:00 pm in the City Hall Council Chambers located at 115 N Fillmore to consider public comment regarding the proposal, and FURTHERMORE, BE IT RESOLVED by the City Council of the City of Osceola that the City Clerk is directed to prepare, publish, and distribute the Notice of Hearing.

ORDINANCE NO. 601 AN ORDINANCE AMENDING CHAPTER 122 OF THE CITY OF OSCEOLA CODE OF ORDINANCES PERTAINING TO MOBILE FOOD UNITS.

BE IT ENACTED by the City Council of the City of Osceola, Iowa:SECTION 1. SECTION MODIFIED. Chapter 122 of the Code of Ordinances of the City of Osceola, Iowa is hereby repealed and the following adopted in lieu thereof: CHAPTER 122 PEDDLERS, SOLICITORS, TRANSIENT MERCHANTS, AND MOBILE FOOD UNITS 122.01 Purpose 122.12 Revocation of License 122.02 Definitions 122.13 Notice 122.03 License Required 122.14 Hearing 122.04 Application for License 122.15 Record and Determination 122.05 License Fees; Other Requirements 122.16 Appeal 122.06 Bond Required 122.17 Effect of Revocation 122.07 Mobile Food Unit License 122.18 Rebates 122.08 License Issued 122.19 License Exemptions 122.09 Display of License 122.20 Charitable and Nonprofit Organizations 122.10 License Not Transferable 122.21 Operation of Mobile Food Units 122.11 Time Restriction

122.01 PURPOSE. The purpose of this chapter is to protect residents of the City against fraud, unfair competition and intrusion into the privacy of their homes by licensing and regulating peddlers, solicitors and transient merchants. 122.02 DEFINITIONS. For use in this chapter the following terms are defined: 1. "Peddler" means any person carrying goods or merchandise who sells or offers for sale for immediate delivery such goods or merchandise from house to house or upon the public street. 2. "Solicitor" means any person who solicits or attempts to solicit from house to house or upon the public street any contribution or donation or any order for goods, services, subscriptions or merchandise to be delivered at a future date. 3. "Transient merchant" means any person who engages in a temporary or itinerant merchandising business and in the course of such business hires, leases or occupies any building or structure whatsoever, or who operates out of a vehicle which is parked anywhere within the City limits. Temporary association with a local merchant, dealer, trader or auctioneer, or conduct of such transient business in connection with, as a part of, or in the name of any local merchant, dealer, trader or auctioneer does not exempt any person from being considered a transient merchant. 4. "Mobile Food Unit" means a food establishment that is self-contained, with the exception of grills and smokers, and readily movable, which either operates up to three consecutive days at one location or returns to a home based of operation at the end of each day. 122.03 LICENSE REQUIRED. Any person engaging in peddling, soliciting, in the business of a transient merchant or operating a Mobile Food Unit in the City without first obtaining a license as herein provided is in violation of this chapter. 122.04 APPLICATION FOR LICENSE. An application in writing shall be filed with the Police Chief for a license under this chapter. Such application shall set forth the applicant's name, permanent and local address and business address if any. The application shall also set forth the applicant's employer, if any, and the employer's address, the nature of the applicant's business, the last three places of such business and the length of time sought to be covered by the license. An application fee of five dollars (\$5.00) shall be paid at the time of filing such application to cover the cost of investigating the facts stated therein. 122.05 LICENSE FEES; OTHER REQUIREMENTS. The following license fees shall be paid to the Police Chief prior to the issuance of any license. 1. Solicitors. In addition to the application fee for each person actually soliciting (principal or agent), a fee for the principal of twenty dollars (\$20.00) per year. 2. Peddlers, Transient Merchants or Mobile Food Units. In addition to the license issuing fee of \$1.00:

- A. For one day \$ 20.00
- B. For one week \$ 20.00
- C. For one month \$ 60.00
- D. For one year \$ 200.00

3. Background Checks. The Department of Criminal Investigation is the only agency authorized by the State to issue criminal background checks. A completed criminal record history must accompany the transient merchant application. Sales Tax. When taxable items are sold, tax must be collected and remitted to the State of Iowa. The total sales tax rate in the City limits of Osceola is 7%. Box 10457 Des Moines, IA 50306-0457 (515) 281-3114 1-800-367-3388 [www.state.ia.us/tax/educate/faqsales.html](http://www.state.ia.us/tax/educate/faqsales.html) 122.06 BOND REQUIRED. Before a license under this chapter is issued to a transient merchant, an applicant shall provide to the Police Chief evidence that the applicant has filed a bond with the Secretary of State in

accordance with Chapter 9C of the Code of Iowa. 122.07 \ MOBILE FOOD UNIT LICENSE. Before a license under this chapter is issued to a Mobile Food Unit, an applicant shall provide to the Police Chief evidence that the applicant has license to operate as a Mobile Food Unit through the Iowa Department of Inspection and Appeals. 122.08 LICENSE ISSUED. If the Police Chief finds the application is completed in conformance with the requirements of this chapter, the facts stated therein are found to be correct and the license fee paid, a license shall be issued immediately. 122.09 DISPLAY OF LICENSE. Each solicitor or peddler shall keep such license in possession at all times while doing business in the City and shall, upon the request of prospective customers, exhibit the license as evidence of compliance with all requirements of this chapter. Each transient merchant shall display publicly such merchant's license in the merchant's place of business. 122.10 LICENSE NOT TRANSFERABLE. Licenses issued under the provisions of this chapter are not transferable in any situation and are to be applicable only to the person filing the application. 122.11 TIME RESTRICTION. All peddler's and solicitor's licenses shall provide that said licenses are in force and effect only between the hours of 8:00 a.m. and 5:00 p.m. 122.12 REVOCATION OF LICENSE. After notice and hearing, the Police Chief may revoke any license issued under this chapter for the following reasons: 1. Fraudulent Statements. The licensee has made fraudulent statements in the application for the license or in the conduct of the business. 2. Violation of Law. The licensee has violated this chapter or has otherwise conducted the business in an unlawful manner. 3. Endangered Public Welfare, Health or Safety. The licensee has conducted the business in such manner as to endanger the public welfare, safety, order or morals. 4. State License. A Mobile Food Unit whose license issued by the Iowa Department of Inspection and Appeals has either lapsed, terminated, or is otherwise no longer valid. 122.13 NOTICE. The Police Chief shall send a notice to the licensee at the licensee's local address, not less than ten (10) days before the date set for a hearing on the possible revocation of a license. Such notice shall contain particulars of the complaints against the licensee, the ordinance provisions or State statutes allegedly violated, and the date, time and place for hearing on the matter. 122.14 HEARING. The Police Chief shall conduct a hearing at which both the licensee and any complainants shall be present to determine the truth of the facts alleged in the complaint and notice. Should the licensee, or authorized representative, fail to appear without good cause, the Police Chief may proceed to a determination of the complaint. 122.15 RECORD AND DETERMINATION. The Police Chief shall make and record findings of fact and conclusions of law, and shall revoke a license only when upon review of the entire record the Police Chief finds clear and convincing evidence of substantial violation of this chapter or State law. 122.16 APPEAL. If the Police Chief revokes or refuses to issue a license, the Police Chief shall make a part of the record the reasons therefor. The licensee, or the applicant, shall have a right to a hearing before the Council at its next regular meeting. The Council may reverse, modify or affirm the decision of the Police Chief by a majority vote of the Council members present and the Police Chief shall carry out the decision of the Council. 122.17 EFFECT OF REVOCATION. Revocation of any license shall bar the licensee from being eligible for any license under this chapter for a period of one year from the date of the revocation. 122.18 REBATES. Any licensee, except in the case of a revoked license, shall be entitled to a rebate of part of the fee paid if the license is surrendered before it expires. The amount of the rebate shall be determined by dividing the total license fee by the number of days for which the license was issued and then multiplying the result by the number of full days not expired. In all cases, at least five dollars (\$5.00) of the original fee shall be retained by the City to cover administrative costs. 122.19 LICENSE EXEMPTIONS. The following are excluded from the application of this chapter. 1. Newspapers. Persons delivering, collecting for or selling subscriptions to newspapers. 2. Club Members. Members of local civic and service clubs, Boy Scout, Girl Scout, 4-H Clubs, Future Farmers of America and similar organizations. 3. Local Residents and Farmers. Local residents and farmers who offer for sale their own products. 4. Students. Students representing the Clarke Community School District conducting projects sponsored by organizations recognized by the school. 5. Route Sales. Route delivery persons who only incidentally solicit additional business or make special sales. 6. Resale or Institutional Use. Persons customarily calling on businesses or institutions for the purposes of selling products for resale or institutional use. 122.20 CHARITABLE AND NONPROFIT ORGANIZATIONS. Authorized representatives of charitable or nonprofit organizations operating under the provisions of Chapter 504A of the Code of Iowa desiring to solicit money or to distribute literature are exempt from the operation of Sections 122.04 and 122.05. All such organizations are required to submit in writing to the Police Chief the name and purpose of the cause for which such activities are sought, names and addresses of the officers and directors of the

organization, the period during which such activities are to be carried on, and whether any commissions, fees or wages are to be charged by the solicitor and the amount thereof. If the Police Chief finds that the organization is a bona fide charity or nonprofit organization the Police Chief shall issue, free of charge, a license containing the above information to the applicant. In the event the Police Chief denies the exemption, the authorized representatives of the organization may appeal the decision to the Council, as provided in Section 122.15 of this chapter. 122.21 OPERATION OF MOBILE FOOD UNITS. It shall be unlawful for any Mobile Food Unit to operate on city owned public property or in the public right of way, except for the following: 1. A Mobile Food Unit may operate on city owned public property or the public right of way as part of any approved Special Event Permit. 2. A Mobile Food Unit may operate on the premises of the Osceola Passenger Depot located on Parcel "C" lying in a portion of Lots 6 In Block 3 of Original Osceola. SECTION 2. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional. SECTION 3. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.

Resolution 2019-05 TO FIX A TIME AND A DATE FOR A PUBLIC HEARING FOR THE PROPOSED AMENDMENT TO CHAPTER 69 OF THE CITY OF OSCEOLA CODE OF ORDINANCES. THE CITY COUNCIL OF THE CITY OF OSCEOLA, IA HEREBY RESOLVES that: Section 1. A Public Hearing will be held as part of the regularly scheduled City Council meeting on Tuesday, February 5th at 7:00 PM to inform the public on the proposed amending of Chapter 69.07 of the City of Osceola Code of Ordinances, titled "Parking Prohibited". The proposed amendment would add to the parking code the prohibition against parking a commercial vehicle on a residential lot. Section 2. The City Clerk is hereby directed to give notice of the proposed hearing, setting forth the purpose, the time when and place where the hearing will be held, by publication at least once and not less than 4 nor more than 20 days before the date of the hearing, in a legal newspaper which has a general circulation in the City.
