The Use Of Condemnation As May Be Necessary To Achieve The Property Acquisition For Accomplishing The Public Improvement Is Hereby Authorized. Section 4. The City Administrator And Acquisition Agent Are Hereby Directed To Undertake Any And All Lawful Acts To Accomplish The Project In Accordance With The Laws Of The State Of Iowa, And To

Acquire All Necessary Property, Including Agricultural Property, Necessary In Regard To The Osceola Airport Project Including All Or Any Part Of The Land Above Described. Section 5. That The City Administrator Is Hereby Authorized To Secure Appraisals Of All Lands Which May Need To Be Acquired And Is Further Hereby Directed And Authorized To Do All Things Necessary To Effectuate The Acquisition Of The Necessary Property Interests, Including By Condemnation If Necessary.

RESOLUTION NO.2018-28 Resolution Taking Additional Action on proposal to enter into General Obligation Annual Appropriation Water Loan Agreement WHEREAS, the City heretofore proposed to enter into a General Obligation Annual Appropriation Water Loan Agreement pursuant to the provisions of Section 384.24A of the Code of Iowa, and to borrow money thereunder in a principal amount not to exceed \$4,500,000 for the purpose of paying the costs, to that extent, of acquiring real and personal property for a waterworks reservoir project to provide potable water to the residents of the City and paying for costs related to the issuance (the "Project") and pursuant to law and a notice duly published, the City Council has held a public hearing on such proposal on May 15, 2018; and NOW, THEREFORE, Be It Resolved by the City Council of the City of Osceola, as follows: Section 1. The City Council hereby determines to enter into the General Obligation Annual Appropriation Water Loan Agreement in the future and orders that bonds or notes be issued at such time, in evidence thereof. The City Council further declares that this resolution constitutes the "additional action" required by Section 384.24A of the Code of Iowa. Section 2. All resolutions or parts thereof in conflict herewith are hereby repealed to the extent of such conflict. Section 3. This resolution shall be in full force and effect immediately upon its adoption and approval, as provided by law.

RESOLUTION NO. 2018-29 Resolution authorizing the use of a preliminary official statement for the sale of bonds WHEREAS, the City of Osceola (the "City"), in Clarke County, State of Iowa, has heretofore proposed to enter into a General Obligation Annual Appropriation Water Loan Agreement (the "Loan Agreement"), pursuant to the provisions of Section 384.24A of the Code of Iowa, and to borrow money thereunder in a principal amount not to exceed \$4,500,000 for the purpose of paying the costs, to that extent, of acquiring real and personal property for a waterworks reservoir project to provide potable water to the residents of the City and paying for costs related to the issuance (the "Project"), and pursuant to law and a notice duly published, the City Council has held a public hearing on such proposal on May 15, 2018; and WHEREAS, a Preliminary Official Statement (the "P.O.S.") has been prepared to facilitate the sale of General Obligation Annual Appropriation Water Bonds, Series 2018 (the "Bonds") in evidence of the obligation of the City under the Loan Agreement, and it is now necessary to make provision for the approval of the P.O.S. and to authorize its use by D.A. Davidson & Co., Des Moines, Iowa (the "Underwriter") as the underwriter for the issuance of the Bonds; NOW, THEREFORE, Be It Resolved by the City Council of the City of Osceola, Iowa, as follows: Section 1. The City Clerk is hereby authorized to take such action as shall be deemed necessary and appropriate, with the assistance of the Dorsey & Whitney LLP (the "Disclosure Counsel"), as bond and disclosure counsel to the City, and the Underwriter, to prepare the P.O.S. describing the Bonds and providing for the terms and conditions of their sale, and all action heretofore taken in this regard is hereby ratified and approved. Section 2. The use by the Underwriter of the P.O.S. relating to the Bonds in substantially the form as has been presented to and considered by the City Council is hereby approved, and the Underwriter, together with Disclosure Counsel, is hereby authorized to prepare and use a final Official Statement for the Bonds substantially in the form of the P.O.S. but with such changes therein as are required to conform the same to the terms of the Bonds and the resolution, when adopted, providing for the sale and issuance of the Bonds, and the City Administrator and/or City Clerk are hereby authorized and directed to execute a final Official Statement for the Bonds, if requested. The P.O.S. as of its date is deemed final by the City within the meaning of Rule 15(c)(2)-12 of the Securities and Exchange Commission. Section 3. Further action with respect to the Loan Agreement is hereby adjourned to subsequent City Council meetings. Section 4. All resolutions or parts of resolutions in conflict herewith are hereby repealed to the extent of such conflict. Section 5. This resolution shall be in full force and effect immediately upon its adoption and approval, as provided by law.

ORDINANCE NO. 591 AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF OSCEOLA, IOWA, BY AMENDING CHAPTER 69.07 TITLED PROHIBITED PARKING BE IT ENACTED by the City Council of the City of Osceola, Iowa: SECTION 1. NEW SECTION. The Code of Ordinances of the City of Osceola, Iowa, is amended by adding a new Sub-Sections to 69.07, entitled PARKING PROHIBITED, which is hereby adopted to read as follows: 69.07PARKING PROHIBITED. No one person shall stop, stand or park a vehicle, except when necessary to avoid conflict with other traffic or in compliance with the directions a peace officer, in any of the following zones: New Sub-Section:(42) A space of fifty (50) feet is hereby reserved on the west side of the 300 Block of N Main adjacent and abutting to the north 50 feet of Lot 12 in Block 4 of North Osceola, within which space no motor vehicle shall be left standing, parked or stopped except in taking on or discharging passengers or freight, and then only for such length of time as is necessary for such purpose. SECTION 2. SECTION AMENDED. The Code of Ordinances of the City of Osceola, Iowa is amended by amending Chapter 69.07 (6) to read as follows:6. Intersection. Within an intersection or within thirty five (35) feet of an intersection of any street or alley. SECTION 3. REPEAL. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed. SECTION 4. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional. SECTION 5. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
