Ordinance 663

AN ORDINANCE PROVIDING FOR THE VACATION AND CONVEYANCE OF AN ALLEY IN THE CITY OF OSCEOLA, IOWA. BE IT ORDAINED by the City council of Osceola, Iowa: SECTION I. PURPOSE. The purpose of this Ordinance is to vacate and convey the described alley and thereby relieve the City of Osceola, Iowa, of the responsibility of its maintenance and supervision, and to promote the orderly development of Osceola, Iowa. SECTION II. FACTS FOUND The Council of the City of Osceola, Iowa herby makes the following findings: a. The described street is not needed for the use of the public. b. The street is presently not open and it would be better used if vacated and conveyed to the adjourning landowners. c. The vacation of said street will not deny owners of property abutting on the street reasonable access to their property. d. The City Council has published notice of the intended vacation once in a newspaper published in and having general circulation in the City and said publication appearing not less than four nor more than twenty days before the date set for the hearing. e. The abutting landowners have petitioned the City Council to vacate and convey said area f. There have been no objections filed in City Hall or with any city personnel. g. The City will retain a utility easement. SECTION III. VACATION The following described alley is hereby declared vacated: South Half of the North/South Alley in Block 5 of N Osceola SECTION IV. CONVEYANCE This Ordinance herby authorizes conveyance of said property to the adjoining proprietors by Quit Claim Deed. Any and all Quit Claim Deeds executed by the said Mayor and City Clerk subsequent to the effective date of this date of this Ordinance, conveying, or purporting to convey, all or any portion of the alley vacated herein, shall be conclusively presumed to be a conveyance to an eligible purchaser of the named grantee to so purchase said land and shall not be subject to attack nor contesting. RESOLUTION AUTHORIZING EXECUTION OF AND DIRECTING SERVICE OF NOTICES UNDER IOWA CODE SECTION 447.9 RELATED TO TAX SALE CERTIFICATE HELD BY THE CITY OF OSCEOLA WHEREAS, the City of Osceola, Iowa (the "City") has acquired a tax sale certificate (the "Tax Sale Certificate") issued following the "public bidder" sale conducted by Clarke County Treasurer on June 17, 2019, pursuant to Iowa Code Section 446.18; and WHEREAS, Iowa Code Section 447.9

provides that notices regarding the expiration of the right of redemption related to the Tax Sale Certificate may be served beginning nine months after the date of tax sale; and WHEREAS, Iowa Code Section 447.9 requires the City Council, by resolution, to designate a city officer to sign such notices. NOW THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF OSCEOLA IN THE STATE OF IOWA:

Section 1. That this Council does hereby authorize Jenna Sabroske, Ahlers & Cooney, P.C., as Special Counsel to the City, to execute the required notices regarding the expiration of the right of redemption related to the Tax Sale Certificate, consistent with Iowa Code Section 447.9. Section 2. That the Special Counsel and City Clerk are hereby authorized and empowered to cause said notices to be served upon the persons identified in Iowa Code Section 447.9 and in the manner directed by Iowa Code Section 447.9, including service by regular mail and certified mail and, if required, service by publication consistent with Iowa Code Section 447.10. Section 3. That, following the service of notices described in Section 2 hereof, the City Attorney is hereby authorized and directed to file an affidavit regarding such service with respect to the Tax Sale Certificate with the Clarke County Treasurer consistent with Iowa Code Section 447.12.
