Local Course rules:

- NO carts close to greens and not on tees or in hazards
- Repair all ball marks on greens
- Replace divots in fairway
- Rake Bunkers after use
- Ball in ditch – one (1) stroke penalty (layout)
- In-course out of bounds hole #7
 - White stakes along right tree line, collect ball and vacate hole #5
 - One (1) stroke penalty (lay out nearest point of exit)
- Mark Scores after leaving
