Note: Actual/Assessed Valuation is multiplied by a Rollback Percentage to get to the Taxable Valuation to calculate Property Taxes. Residential and Commercial properties have the same Rollback Percentage at \$100,000 Actual/Assessed Valuation.

**Reasons for tax increase if proposed exceeds the current:**

The proposed levy rate for FY 26 represents an approximate increase of 2%. This State-required notice is grossly inaccurate, property valuations are not increasing by 10%.
